



CONTRIBUTOR AGREEMENT

Dear Contributor(s): Thank you for agreeing to contribute to *The Encyclopedia Of Women And Crime*. Please print this Agreement, ensure that you and any co-contributors sign, scan and email to **Editorial Office** at ewac@jeditorial.com. Please note that publication cannot proceed without a signed Contributor Agreement. If the Contribution is not accepted for publication or is subsequently rejected, this Agreement shall be null and void.

AGREEMENT between **Raymond Delaney** and **Debbie Ferguson** whose address is:

(the "Contributor" which expression shall where the context admits include joint contributors) and John Wiley & Sons, Inc., 111 River Street, Hoboken, New Jersey 07030 USA (the "Publisher").

The Contributor has agreed to prepare an original and previously unpublished contribution in the English language (the "Contribution") on the subject of DIVERSION PROGRAMS for inclusion in the forthcoming work tentatively entitled *The Encyclopedia Of Women And Crime* (the "Work"), edited by **Professor Frances Bernat and Professor Kelly Frailing** (the "Editor(s)"), to be published by the Publisher.

The terms are as follows:

The Contribution shall consist of approximately **3000** words including all figures and any supplementary materials agreed with the Publisher and shall be prepared in accordance with the Contributor Instructions provided by the Publisher. The Contribution shall be submitted not later than **11/25/2016**, unless the Publisher has agreed to extend the time in writing (the "Due Date"). Upon completion of the review of the Contribution, the Contribution will be returned to the Contributor for revision and the Contributor will revise the Contribution in accordance with the reviewer's instructions or advice. Upon completion of the revision of the Contribution by the Contributor, the Contributor will submit the final version of the Contribution to an online submission and peer-review website specified by the Publisher, complete and satisfactory to the Publisher in organization, form, content and style within four weeks of receipt of the review. At the request of the Publisher, the Contributor may be required to read and correct the proofs for the Contribution and return them to the Publisher within 14 days of receipt, failing which the Publisher may agree with the relevant Associate Editor ("Associate Editor") to dispense with such proof corrections. The Contributor authorises the Publisher, the Editor and the Associate Editor to make any amendments to the Contribution which the Publisher may deem desirable in the interests of uniformity and style of the Work. The Contributor shall be responsible for obtaining and paying for all necessary permissions to use any third party copyright material in the Contribution. Any fonts used in material delivered to the Publisher in printer-ready form or otherwise intended to be reproduced in the form whether in print or digitally shall be considered part of the Work and shall be limited to fonts from Adobe Font Folio 11 and/or approved open-source fonts. On the Due Date, Author shall deliver a list of all fonts included in any such materials delivered to the Publisher

As full and final consideration for all rights transferred and all services provided by the Contributor under this Agreement the Publisher shall

provide each Contributor with one complimentary one year subscription to the online edition of the Work from the date of on-line publication and for any period thereafter during which Contributor is: (i) actively preparing Updates; or (ii) available to prepare Updates, and the Publisher agrees that such Updates may be desired from the Contributor, for personal, non-commercial, use only. As compensation for the Contributor's services under this Agreement, the Contributor will be entitled to select print books published by the Publisher ("Books") to the value of \$150 in the case of total Contributions of less than 3000 words in total, or, Books to the value of \$200 in the case of total Contributions between 3001 and 5000 words in total, or, Books to the value of \$250 in the case of total Contributions between 5001 and 9999 words in total, or Books to the value of \$300 in the case of total Contributions of more than 10,000 words, upon publication of the Work; such compensation will be based on the total number of words accepted for publication. The Contributor may purchase, for personal use only, copies of (i) the print edition of the Work at a discount of 25% and (ii) many other books published by the Publisher at a discount of 25% off the then current US list price.

To receive the Wiley Contributor discount, the Contributor must register on the Resources for Authors site at www.wiley.com/go/authordiscount. After completion, the Contributor will receive an email containing a unique discount code which can be used when shopping on Wiley.com.

The Contributor hereby assigns to the Publisher for the full period of copyright and all extensions and renewals (where relevant by way of present assignment of future copyright) the entire copyright and all other rights of whatever nature in and to the Contribution throughout the world including, but not limited to, the right to copy, store and publish the Contribution as part of the Work, or in derivative works based on the Work, or in compilations with other works, or as a condensed version and to issue, rent, sell, transmit and distribute copies of such Contribution to the public in all languages and in all

media of expression now known or later developed, and to sub-license or permit others to do so.

The Contributor represents and warrants to the Publisher (1) except as disclosed otherwise to the Publisher the Contribution has not been previously published; (2) the Contributor is the sole owner of all rights in the Contribution except for excerpts and illustrations from other copyright works for which the Contributor has obtained written permission from the copyright owners to use in the Contribution; (3) the Contribution contains nothing which is libellous, in breach of any obligation of confidentiality or official secrets acts or anything which would constitute a malicious falsehood or is otherwise unlawful and (4) publication and use of the Contribution will not infringe the copyright, trademark, trade secret, right of privacy or publicity, or any other rights of any third party.

The Contributor may send or transmit individual copies of the Contribution in any format to colleagues provided no fee is charged and further provided that there is no systematic distribution of the Contribution, for example: posting on a listserve, or automated delivery system or networks (including social media networks). The Contributor has the right to include the Contribution in teaching or training duties at the Contributor's institution/place of employment including in course packs, e-reserves, presentation at professional conferences, in-house training, or distance learning. The Contribution may not be used in seminars outside of normal teaching obligations (for example in commercial seminars), without express written permission from the Publisher. The Contributor may make oral presentations based on the Contribution and may re-use all or part of the final Contribution in any other publication authored or edited by the Contributor (excluding journal articles) where such re-used material constitutes less than half of the total material in such publication. In such case, any modifications should be accurately noted.

The Contributor may re-use figures, tables, data sets, and artwork from the Contribution, provided the following conditions are met: (i) full and accurate credit must be given to the Contribution; (ii) modifications to the figures, tables and data must be noted; (iii) the reuse may not be made for direct commercial purposes; and (iv)

nothing herein shall permit dual publication in other works or in violation of publishing ethics.

The Publisher licenses back the following right to the Contributor in the version of the Contribution as originally submitted for publication: The right to self-archive on the Contributor's personal website or in the Contributor's institutional repository or archive. This right extends to both intranets and the Internet. The Contributor may not update the submission version or replace it with the published Contribution. The version posted must acknowledge acceptance for publication and, following publication of the final Contribution, contain a legend as follows: This is the submitted version of the following book chapter: FULL CITE, which has been published in final form in [Link to Companion page on Wiley.com]. Posting the final published version of the Contribution on the open Internet is not permitted without the express written permission of the Publisher.

If the Publisher fails to publish the Work for any reason, all rights transferred or granted to the Publisher under this assignment will automatically and immediately revert to the Contributor absolutely. If the Contributor fails to deliver the Contribution to the Publisher by the Due Date in a form acceptable to the Publisher the Publisher may terminate this Agreement by notice in writing. The Publisher will have the final decision as to the inclusion or omission of the Contribution in or from the first and any subsequent editions of the Work. The Publisher may request the Contributor to update the Contribution but shall be at liberty to engage another suitably qualified person to update the Contribution, provided that the Contributor shall be credited as the author of the original Contribution.

Where there is more than one Contributor to a Contribution each such Contributor's obligations, warranties and undertakings under this Agreement shall be joint and several and any sums payable by the Publisher to the Contributor shall be divided equally between the Contributors unless the Publisher is authorized to the contrary in writing by each Contributor.. In the event of any disagreement between the Contributors which prevents or delays submission of the Contribution by the Due Date or otherwise interferes with the publication of the Work, the Publisher may, in its sole discretion, determine how the disagreement will be resolved and its determination will be final.

This agreement shall be governed by New York State law and shall be effective from the date of the Contributor's signature written below.
